The following terms and conditions shall apply;

- 1. The vehicles may be viewed two working days before the set auction date. There will be no viewing of vehicles on the auction date.
- 2. All auctions will start at 8.30am.
- 3. All vehicles will be sold with a reserve price and only bids equivalent or above the reserve price will be considered.
- 4. Vehicles will be sold to citizens of Botswana & wholly citizen owned companies only (certified proof required). Each citizen or wholly citizen owned company will be allowed to purchase a maximum of two auction vehicles at a time (per cycle per site).
- 5. Bidders who have purchased two vehicles in one station or two separate stations must not go to another auction site to bid for a third vehicle.
- 6. Prospective bidders shall pay a refundable deposit of P5, 000.00 (five thousand pula) in form of a bank certified cheque or cash for each intended purchase. (E.g. a bidder wishing to buy 2 vehicles should pay a total of (P10, 000.00) ten thousand in advance as deposit.

- 7. Only those potential bidders who have paid the required deposit and have been issued with the official receipt will be allowed into the auction yard.
- 8. A bidding card shall be issued for each intended purchase. Bidders shall not be allowed to sell their bidding cards to anybody.
- 9. Collection of deposits at all stations shall be conducted a day before the auction date. No deposits shall be collected on the auction day.
- 10. Deposits shall be returned to unsuccessful bidders immediately after the auction.
- 11. The bidder whose name appears on the official deposit receipt shall be the only one allowed to claim back the deposit.
- 12. In order to claim back the deposit, each bidder must produce the official receipt issued to them as well as the bidding card.
- 13. Payment for a lot shall be made by bank guaranteed/certified cheque or cash for the full amount within three working days of the sale including the day of the sale.
- 14. Any successful bidder who fails to make payment within three working days will lose his or her deposit (P5, 000.00) per vehicle. If the vehicle is not paid for, the next preferred bidder will be offered at his/her offer bid price.
- 15. Bank guaranteed/ certified cheques for the auctioned amount (selling price) must be made payable to Botswana Unified Revenue Service.
- 16. Vehicles (lots) may only be removed from BURS premises upon presentation of an official receipt of payment.
- 17. A successful bidder shall become the owner of the vehicle immediately upon payment for the lot.
- 18. After full payment has been effected, BURS will issue all the necessary documents to facilitate in the transfer of ownership of the vehicle. Transfer of ownership from the successful bidder to a different person or company will only be allowed 12 (twelve) months after vehicles are bought from BURS.

- 19. BURS shall not be responsible for the safe custody of sold vehicles, therefore sold vehicles must be collected at least two days after full payment is done. Otherwise, a penalty of P200.00 per day after the stipulated collection period (3 days) will be charged for storage.
- 20. The handling and removal of the sold vehicles shall be at the sole risk and expense of the purchaser.
- 21. All vehicles are offered in "as is" condition without warranty or guarantee of any kind expressed or implied as to age, year of manufacture, model, condition etc.
- 22. Items will be sold in lot numbers to the highest bidder. BURS reserve the right to reject any bid whether or not the highest.
